WELCOME.

The Chair welcomed everyone to the meeting. The Chair reminded the Members of the Public that there is a slot on the agenda for them to raise issues and to please not interject during the meeting.

DECLARATION OF INTEREST.

The Chair referred to a recent email from Test Valley Borough Council Legal and Democratic Services regarding the Declarations of Interests signed by Parish Councillors which needs to be reviewed on an annual basis. However, as this is not an election year, Councillors do not need to complete a new form. However, Councillors are to confirm whether there are any amendments required. It was recorded that all Councillors confirmed that there were no amendments and no current Declarations of Interest.

MINUTES OF THE PREVIOUS MEETING.

The minutes of the April and May AGM Meetings were signed as a true record. Matters arising from those minutes that require an up-date:

PLAY AREA UPDATE

Test Valley Borough Council have sent the Parish Council a draft lease for the Locke Close Play Area. The Parish Council were shocked to read that TVBC want the Parish Council to take over the maintenance and responsibility for the boundary of the Locke Close Field. The Parish Council were concerned about the cost implications for the Parish.

The Parish Council will hold an 'in-camera' meeting to discuss their response to TVBC.

Borough Councillor Mrs M Flood asked that she be sent a copy of the draft lease and that would speak to the Estates and Legal Departments at TVBC

HIGHWAYS.

The Chair stated that he had reported the issues brought up at the AGM by Mr Peter Blakeman to Highways, however, they require photographic evidence and plans to enable them to locate the areas of concern that can be forwarded onto Highways. The Chair asked Cllr Mrs J Blackman if she could ask Mr Peter Blackman to contact him.

Cllr Mr I Wingfield reported that the Traffic Group met on the 29th of May 2024 and would like to proceed with the purchase of 30MPH wheely bin stickers. The Parish Council after some discussion agreed but were concerned about the cost of the stickers. Cllr I Wingfield stated that he will investigate to get the best possible price.

Overgrown Signs – The Lengthsman will be asked to cut back vegetation from the Village Signs. The 40MPH warning sign on the Wallop Road from Over Wallop direction is barley visible. The 'Please Drive Slowly through the Village' sign on the Cholderton Road has disappeared into the hedge. An overgrown Footpath Sign in Streetway Road will also be added to the list.

Cllr M Horne reported that the Monxton Road adjacent to the Golf Driving Range is in urgent ned of attention. There are large potholes that fill up with water after rainfall and the white lines have disappeared. The Chair will add this to his correspondence with Hampshire Highways.

Cllr I Wingfield gave the Speed Sign data for the last month.
